## FBI Fraud Alert

Questions to Ask Yourself

In light of the increasing number of fraudulent scams being circulated throughout the world on a daily basis via the internet or mail the FBI has put together this excellent check list. If you can answer "yes" to any of the following questions, you could be involved in a fraud or about to be scammed!

- Are you receiving pay or a commission for facilitating money transfers through your account?
- Did you receive the check via an overnight delivery service?
- Did you respond to an email requesting you to confirm, update, or provide your account information?
- Have you been asked to pay money to receive a deposit from another country such as Canada, England, or Nigeria?
- Have you been informed that you were the winner of a lottery that you did not enter, such as:
  - Australian
  - Canadian
  - El Gordo
  - El Mundo
- Have you been instructed to either wire, send or ship money, as soon as possible, to a large U.S. city or to another country, such as Canada, England, or Nigeria?
- Is the amount of the check more than the item's selling price?
- Is the check connected to communicating with someone by email?
- Is the check drawn on a business or individual account that is different from the person buying your item or product?
- Is the check from an item you sold on the internet, such as a car, boat, jewelry, etc.?

## <u>Pet Safety</u>

Winter is upon us and with it comes freezing temperatures, snow and ice, that can endanger the well-being, safety, and the lives of the pets we love.

During extreme cold bursts, it's important to take cold-weather precautions to protect your pets:

## 1. Keep outdoor trips quick

For bathroom breaks or walks, make it short and sweet, and keep your pets indoors as much as possible.

## 2. Check under the hood

Cats love to warm up underneath the hood of a car, as the residual heat from the engine burns off. Unfortunately, this method of warming up can have dangerous consequences, such as severe burns and other grave injuries. Always pound on the hood of your vehicle and do a quick visual check before starting the engine.

## 3. Never leave your dog alone in a cold car

Many Massachusetts residents are aware that it's illegal to keep an animal in a hot car. But did you know... that under the same law it's ALSO illegal to keep your animal in a cold car? MA. Ch. 140, Section 174F states that a person shall not confine an animal in a motor vehicle in a manner that could reasonably be expected to threaten the health of the animal due to exposure to extreme heat or cold. When going out, leave your animals at home.

### Bottom line, if it's too cold for you to be outside, it's also too cold for your pet to be outside.

Did you know, Massachusetts has an anti-tethering statue? This indicates that dogs cannot be confined outside when a weather advisory, warning, or watch is issued by local, state, or federal authority; or when environmental conditions such as extreme heat, cold, rain, snow, or hail pose as adverse risk to health or safety of the dog, based upon the dog's breed, age, or physical condition and unless tethered for less than 15 minutes.
