D. Preservation & Redevelopment Initiative (PRI) -

Vice Chair Flanagan updated the Board on the Linden Street Redevelopment Project and the modernization projects of Seabeds Way and Captain Robert Cook Drive. Vice Chair Flanagan noted that the winter 2025 funding for the One Stop application for Phase 1A Linden Street Development was submitted to EOHLC on Thursday, February 27, 2025. Vice Chair Flanagan thanked everyone who contributed to this massive effort.

Vice Chair Flanagan also noted that the Needham Community Preservation Committee approved that an article be added to the Town Meeting Warrant for funding of \$3.2 million from the Community Preservation Act Fund for construction costs and select pre-

development costs associated with the preservation of the 46 affordable public housing units at Seabeds Way.
